THIS IS A RELEASE OF LIABILITY, PLEASE READ CAREFULLY BEFORE AGREEING TO OR ENGAGING IN THIS ACTIVITY.

I/we agree that The Competitor or Person Registering the competitor is at least 18 years old and hereby represents that he/she is the authorized parent/guardian of the competitor.

I/we understand and accept the fact that freestyle skiing and jumping in its various forms is a HAZARDOUS sport that has many risks and dangers. It is further understood that training or jumping competitively is more HAZARDOUS than recreational jumping. I/we realize that injuries are common and ordinary occurrence of this sport. I/we agree, as a condition of being allowed to use the ski area facilities and premises, that I/we freely accept and voluntarily assume all risks of personal injury or death or property damage which result in any way from negligence, conditions on or about the premises and facilities, the operations of the ski area including, but not limited to grooming, snowmaking, ski lift operations actions or omissions of employees, or agents of the area, or competitor's participation in skiing, training any competitive event or any continuance thereof or in the course of travel to or from any such event, or other activities at the ski area.

I/we agree with the premise that a participant is always a competitor, whether practicing from competition or in competition. I/we agree that the competitor is always provided an opportunity to conduct a reasonable physical and visual inspection of the training or racecourse, and I/we agree to inspect the course physically and visually prior to training. I/we agree and understand that the competitor will be held to assume the risk of all conditions including, but not limited to, weather and snow conditions, course construction or layout and obstacles.

I/we freely accept the full responsibility for any damage or injury of any kind which may result and agree to indemnify and hold Lost Valley, all their officers, agents and employees, acting officially or otherwise, harmless for any claim, demand actions or causes of action arising out of, on account of, any injury or damage to said competitor or competitor's property arising from the negligence of breach of warranty express or implied of the above entities and persons affiliated with said entities.

I/WE HAVE CAREFULLY READ AND UNDERSTAND THE TERMS OF THIS RELEASE AGREEMENT, I/WE ARE SIGNING IT FREELY AND REALIZE THAT IS BINDING UPON MYSELF, MY HEIRS AND ASSIGNS. I/WE UNDERSTAND THAT OUR SIGNATURES BELOW EXPRESSLY WAIVE ANY RIGHTS I/WE HAVE TO SUE LOST VALLEY, ITS EMPLOYEES, CONTRACTORS, OR SPONSORS FOR INJURIES AND DAMAGES.
